

MEDICAL/DENTAL SERVICES AND PRESCRIPTION MEDICATIONS PROVIDED AT NO COST TO THE SICK, UNINSURED AND UNDER-INSURED POOR, AND HOMELESS THROUGH HEALTH CLINICS STAFFED PRIMARILY BY VOLUNTEER, LICENSED HEALTHCARE PROFESSIONALS. BETWEEN JULY 1, 2017 AND JUNE 30, 2018 WE DISPENSED 37,161 PRESCRIPTIONS AND HAD 25,581 PATIENT VISITS AT 15 CLINIC SITES IN 4 STATES.
