MEDICAL/DENTAL SERVICES AND PRESCRIPTION MEDICATIONS PROVIDED AT NO COST TO THE SICK, UNINSURED POOR, AND HOMELESS THROUGH MOBILE HEALTH CLINICS STAFFED PRIMARILY BY VOLUNTEER, LICENSED HEALTHCARE PROFESSIONALS. BETWEEN JULY 1, 2015 AND JUNE 30, 2016 WE DISPENSED 29,883 PRESCRIPTIONS AND HAD 24,632 PATIENT VISITS AT 18 CLINIC SITES IN 4 STATES. THE ORGANIZATION RECEIVED DONATED SERVICES OF \$1,713,729 FROM LICENSED HEALTHCARE PROFESSIONALS THAT PROVIDE THE MEDICAL AND DENTAL SERVICES. IN ADDITION TO DIRECT HEALTHCARE SERVICES PROVIDED FREE TO PATIENTS, THE COMMUNITY CONNECTIONS PROGRAM CONNECTS PATIENTS WITH ADDITIONAL RESOURCES FROM OTHER PARTNER ORGANIZATIONS, HELPING TO PROMOTE GENERAL HEALTH LITERACY, DISEASE MANAGEMENT AND PREVENTION EDUCATION, NUTRITION AND EXERCISE, AND EMPLOYMENT TRAINING. FOR EXAMPLE, DURING FISCAL YEAR 2016, 960 ARIZONA PATIENTS WERE SCREENED FOR HEALTH INSURANCE ELIGABILITY AND/OR REFERRED FOR HOUSING AND FOOD ASSISTANCE.
